On the basis of the Civil Services [Main] Examination, 2017 conducted by the Union Public Service Commission, the President is pleased to provisionally appoint **Sh. Sanjith Kumar (Rank 1042)(OBC)** to the Junior Time Scale of Indian P&T Accounts and Finance Service Group 'A' in the pay scale of PB-3 Rs.15600-39100+5400/- on the following terms:

- [i] He/she will be on probation for a period of 2 years from the date of appointment which may be extended at the discretion of the Competent Authority. During the period of probation, he/she will be required to undergo such training and take such tests as Government may prescribe. Failure to pass the prescribed tests within the period of probation will render him/her liable to be discharged from service or reversion to his/her substantive post on which he/she may be retaining a lien, as the case may be.
- [ii] The appointment will be subject to the submission of a declaration in the prescribed form to the effect that in the event of his/her having more than one wife living or having a spouse living, he/she has married and his/her marriage is void by the reason of its taking place during the life time of such spouse, the appointment will be subject to his/her being exempted from the enforcement of the requirement in this behalf.
- (iii) The appointment of a female candidate will be subject to the submission of a declaration in the prescribed form to the effect that in the event of her marrying a person who has a wife living, the appointment will be subject to her being exempted from the enforcement of the requirement in this behalf.
- [iv] The appointment will be subject to furnishing of information in respect of close relations in the prescribed proforma to be supplied by the NICF. Any change in the particulars given in the proforma to be further intimated at the end of each year.
- [v] Taking of an oath of allegiance /faithfulness to the Constitution of India for making a solemn affirmation to that effect in the prescribed proforma.
- [vi] The appointment carries with it the liability to serve in any part of India.

- [vii] Other conditions of service will be governed by the relevant Rules and orders issued from time to time on the subject.
- 2. This offer of appointment is **provisional** subject to (i) clearance of verification of character and antecedents from the Cadre Controlling Authority i.e. Department of Telecommunications and (ii) the community certificate being verified through the proper channels and if the verification reveals that the claim of the candidate to belong to OBC or not to belong to creamy layer is false, his/ her services will be terminated forthwith without assigning any further reasons and without prejudice to such further action as may be taken under the provisions of the Indian Panel Code for production of false certificates.
- 3 a. In case the enquiry as envisaged under Rule 20 of Civil Services Examination Rules is pending in his/her case, his/her appointment to a service will be subject to he/she being found suitable on the basis such enquiry as may be considered necessary by the Government having regard to his/her character and antecedents.
- 3 b. In case, at any stage, it is found that any certificate or document furnished by him/her and having a bearing on his/her eligibility is not in order or any information/ material facts having bearing on his/her eligibility have been hidden/ misrepresented by him/her, then his/her appointment is liable to be cancelled forthwith without prejudice to any other punitive action under relevant rules.
- 4. The acceptance of this offer or not, is to be intimated to this department without fail. If he/she accepts this offer of appointment, he/she will report to the Director General, National Institute of Communication Finance, opposite Metro Pillar No.-152, Ghitorni, Mehrauli, Gurgaon Road, New Delhi-110047(E-mail:-nicfghitorni@gmail.com) on 10.12.2018 for professional training commencing from 11.12.2018. However, if he/she does not join the professional training, this offer would lapse after expiry of one month from the date of issue of this offer.
- 5. The candidate who has joined the Foundation Course will be deemed to be in service from the date of his/her joining the Foundation Course.
